## 2019 Meetings, Trainings, & Webinars Descriptions

### **Medicare Fundamentals Trainings:**

This half-day, interactive workshop is great for professionals who would benefit from a basic understanding of healthcare options and resources available to older adults or for professionals who are new to the aging field. The workshop provides a review of the following topics:

- Parts of Medicare
- Medicare & Medicaid Eligibility
- What Medicare does not cover (and what Medicaid might)
- Where to refer patients for Medicare counseling and other aging services

The trainings are geared towards professionals new to the field of *counseling* older adults and people with disabilities on their healthcare benefit options or professionals who need a refresher on healthcare benefits. **The program will provide a comprehensive training on how to compare coverage options and conduct enrollment into Medicare Parts A and B, Medicare Savings Programs, Medicare Advantage and Medicare Supplement plans, Medicare Part D, and the Extra Help/Low Income Subsidy Programs.**

### **Medicaid Counselor Trainings:**

The Medicaid Counselor Trainings are one day workshops designed for professionals that help a consumers enroll in healthcare coverage that best suits their needs. The trainings are geared towards professionals new to the field of counseling older adults and people with disabilities on their healthcare benefit options or professionals who need a refresher on healthcare benefits. **The program will provide a detailed overview of Medicaid, Medicaid managed care programs, Medicaid Spenddown and an overview of the Health Insurance Marketplace.**

### **Webinars:**

Our webinars provide a virtual presentation from the comfort of your desk. The webinars will provide an in-depth description on Medicare or Medicaid related topics. The topics will be announced along with the webinar registration.
